

**RACE ACROSS THE WORLD (“Programme”)**  
**APPLICATION TERMS AND CONDITIONS**

By registering your interest and/or commencing your application form for the Programme, you agree to the following terms and conditions (“**Terms**”):

**1. GENERAL**

- 1.1. These Terms relate to your application to take part in the Programme and form part of your application (which shall include the application form and any other items provided by you as part of the casting process). For the purposes of the application form and these Terms, “**we**”, “**us**” and/or “**our**” shall mean Studio Lambert Associates Limited and “**Broadcaster**” shall refer to the BBC, financier and/or distributor of the Programme.
- 1.2. Applications may not be considered if they are incomplete, incomprehensible and/or incorrectly submitted. We do not accept any responsibility whatsoever for any technical failure, malfunction, delays of or any other problem which may result in any application not being properly received by us by the specified closing date or other specified time (where applicable).
- 1.3. Closing Date: The current closing date for applications for the Programme is set out in the application form. We reserve the right to extend or close this application process at any time in our sole discretion for any reason and without notice.
- 1.4. Due to the number of enquiries and/or applications we expect to receive, we cannot guarantee that we will review every application and we will not be able to acknowledge or respond to each and every one. Please note we will only be contacting those applicants who we wish to put forward to the next stage of the casting and selection process. You accept and agree that the casting process and/or applicants and/or contributors selected for the Programme will be at our sole discretion. Applications are not guaranteed to be successful. Our decisions in these matters shall be final and there will be no right of appeal against any decisions taken by us on these matters.
- 1.5. You accept that registering your interest, submitting an application form, receiving any document, a phone call and/or other correspondence, attending an audition/interview, being shortlisted and/or taking part in any recording day and/or any part of the casting process DOES NOT automatically mean that you will be taking part in and/or appearing on the Programme and we reserve the right, at our sole discretion, to stand you down at any time, even if you have been given a date to attend an audition, interview and/or recording.
- 1.6. We and the Broadcaster shall have no obligation to: include any applicant’s participation in the Programme; make use of any of the Contribution and/or Personal Media (as defined below); develop, produce, broadcast or distribute the Programme; or publicise the same.

## 2. YOUR OBLIGATIONS

- 2.1. If you have registered your interest, you will need to complete an application form in order to apply to take part in the Programme. If you are subsequently invited and/or selected to take part in the casting process for the Programme, you agree to:
  - 2.1.1. provide us with a valid and original proof of your age and identity (such as a passport or driving licence) in such form as notified to you, on request. **Please note** if you do not provide us with valid proof of identity as requested, we may be unable to continue with your application and may stand you down from the casting process and/or from participating in the Programme;
  - 2.1.2. attend any casting and/or selection process relating to the Programme on any dates as mutually agreed at such location(s) and/or using such technology (such as by way of example Skype or Facetime or Zoom) as requested by us;
  - 2.1.3. undertake medical and/or psychological assessments, conducted by certified practitioners, if required by us. You further acknowledge and agree that such practitioners shall share their reviews, reports, information, results and/or findings in respect of such assessment with us and we may share the same with the Broadcaster and other authorised third parties as set out in our privacy policy <http://www.studiolambert.com/privacy.html>. You may also be required to complete a criminal records check, provide us with a letter from your GP or medical records, or complete a statement of health and/or health questionnaire;
  - 2.1.4. share such background information about you and your identity as requested by us, (including but not limited to information relating to your background/personal history, family employment, physical and/or mental health, social media, any criminal and/or civil allegations or investigations and/or unspent criminal and/or civil proceedings you have been and/or are involved in and/or any conduct or anything in your past that may attract negative press or publicity, whether for you, us, the Broadcaster and/or the Programme). Please note that disclosing something of this nature to us will not automatically disqualify you from taking part in the casting process and/or the Programme but it is important we know of any relevant issues; and/or
  - 2.1.5. inform us if you are or have been previously employed or engaged by the Broadcaster and/or any company within the All3media Group within the last 5 years and/or if you are an immediate relative of or living with any current or past (within the last 5 years) employee of or worker for the Broadcaster and/or any company within the All3media Group. If you are or have been, you must make this known to us and it will be assessed on a case by case basis to ensure that you would not have an unfair advantage.
- 2.2. You confirm that you shall comply with each of the Eligibility Requirements as set out in the application form and, if requested, shall provide us with documentary evidence as well as providing all consents and/or assistance necessary to carry out any background searches (including but not limited to social media and internet searches) if so required by us to substantiate any information provided by you at any time in your application during the casting process).

- 2.3. You agree that if you are selected to participate in the Programme, you shall promptly sign and return a contributor agreement (in such form as we provide to you) and perform such acts and/or complete such documentation as reasonably requested by us for production purposes for the Programme.
- 2.4. You agree to follow our directions and instructions during the casting and/or selection process and, if selected to take part in the Programme, you agree to abide by any further directions, instructions and/or the rules of the Programme as we may notify to you (whether verbally or in writing). You accept that we may alter, change or add to such directions, instructions and/or rules from time to time in our sole discretion and our decision in these matters are final.
- 2.5. You agree to comply with all applicable laws and regulations in connection with the casting and/or auditioning process and/or if selected your participation in the Programme.
- 2.6. You confirm that:
  - 2.6.1. the information supplied in your application will be true and honest;
  - 2.6.2. you have not and will not deceive or mislead us in any way (including not withholding any information); and
  - 2.6.3. you will continue to be entirely truthful and accurate in answering any questions and/or supplying information to us whether verbally or in writing.
- 2.7. You agree to keep us informed of any change(s) to your circumstances or to any information that you share with us at any time (including but not limited to the application) in connection with the Programme, including any criminal charges, investigations, and/or convictions and/or restraining or non-molestation orders which are brought against you or by you.
- 2.8. We may, in our sole discretion, disqualify you at any time from any stage of the casting process or the Programme itself (if selected) and/or withhold or reclaim any prize or other benefit awarded or due to be awarded to you as a result of your participation in the Programme if:
  - 2.8.1. you do not meet the Eligibility Requirements;
  - 2.8.2. you fail to abide by these Terms and/or, if applicable, the terms of any agreement between you and us and/or the applicable rules of the Programme;
  - 2.8.3. you supply or have supplied any untruthful, incomplete, inaccurate or misleading details and/or information;
  - 2.8.4. you withhold or have withheld any information and/or you have deceive us or have deceived us or the Broadcaster in any way;
  - 2.8.5. you fail to follow any of our reasonable instructions or directions; and/or
  - 2.8.6. by reason of your conduct (including past conduct) you bring us, yourself, the Programme and/or Broadcaster into disrepute, scandal and/or contempt.

### 3. GRANT OF RIGHTS

- 3.1. In the event that you are invited to attend an audition, interview (whether face to face or online), recording and any other subsequent stages of the casting process for the Programme, you agree and consent to us filming and/or recording you and your voice, conversation and sounds (collectively the “**Contribution**”) and using your Contribution for and in connection with casting and/or production of, the Programme, in the Programme and/or associated publicity, whole or in part, or not at all.
- 3.2. You irrevocably grant and assign to us by way of present assignment of present and future copyright, all rights of any nature in and to the rights, title and interest in your Contribution so as to permit the fullest use throughout the world of the Contribution or any part(s) thereof by all means and in all media in connection with the Programme or otherwise in perpetuity.
- 3.3. You also agree that any information, photographs, images, recordings (audio and/or visual) and/or any other materials you submit or share with us as part of the application, casting and/or production process for the Programme and/or as part of your Contribution (“**Personal Media**”) may be used in connection with the casting process and/or production of the Programme (in whole or in part), featured in the Programme and/or associated publicity, or not at all. We are under no obligation to return the Personal Media to you. Furthermore, you grant us a royalty free worldwide perpetual licence for our use of the Personal Media, and you confirm that you have all the necessary licences, rights, consents and permissions (including from any individuals who may feature in the Personal Media) for our use of the Personal Media (in full or in part) in the Programme and shall provide us with details of these on request.
- 3.4. You grant us the right to use your name, voice, likeness, photographs and any biographical material, Personal Media and/or your Contribution for and in connection with the Programme (including without limitation for publicity, promotion and sponsorship of the Programme, any future series of the Programme, and/or any ancillary or merchandising products, services or endorsements) by any medium or method whether now known or later developed throughout the world in all media in perpetuity.
- 3.5. You accept that we have the right to edit, copy, adapt and/or translate the Contribution and Personal Media as we see fit (in accordance with the Ofcom Broadcast Code and the Broadcaster’s Editorial Guidelines) and you irrevocably waive the benefits of and agree not to assert any provision of law known as "moral rights" or any similar laws of any jurisdiction in respect of any Contribution and/or Personal Media.
- 3.6. You confirm that nothing in your application Contribution and/or the Personal Media will:
  - 3.6.1. infringe the copyright or any other right of any third party;
  - 3.6.2. breach any contract or duty of confidence;

- 3.6.3. constitute a contempt of court or expose us to any civil or criminal proceedings; and/or
- 3.6.4. otherwise be intended to bring us, the Broadcaster and/or any other party into disrepute, scandal and/or contempt.

#### **4. CONFIDENTIALITY**

- 4.1. You agree that you will not **at any time** disclose (directly or indirectly) or supply any information or materials (including without limitation any photographs and/or audio and/or visual recordings) to any person (including without limitation the press, friends or family and/or the public) by any means (including without limitation via social media) in relation to: (i) your application and/or the casting process; (ii) the Programme (including but not limited to the name and/or identity of the Broadcaster, any filming and/or production locations, other contributors or applicants, the production crew and/or the outcome of the casting process and/or any activity); (iii) the affairs of us and/or the Broadcaster; and/or (iv) the contents of any and all agreements, correspondence and/or conversations between you and us; which comes to your knowledge as result of your application and/or the casting and production process for the Programme, except where such information may already be legitimately in the public domain, is required by law to be disclosed, or where we have given you our prior written consent.
- 4.2. You further agree not to make any derogatory or critical comments or statements (whether orally or in writing) about the Programme or any person involved with it, us and/or the Broadcaster.

#### **5. MISCELLANEOUS**

- 5.1. By necessity we will process your personal data, including your name, image and voice, together with such special category data you may share with us (such as but not limited to your health, race and/or criminal history) as part of producing the Programme. We will do so in accordance with the relevant data protection law and you can find out more information about how we process your personal data and who we share such information with (such as the Broadcaster and other authorised third parties) on our website <http://www.studiolambert.com/privacy.html>
- 5.2. By providing information to us relating to another person, including but not limited to contact details, you confirm that you have obtained that person's consent to share their information with us and have fully explained to them the purpose of providing the information.
- 5.3. Any costs or expenses incurred by you in respect of applying for the Programme or participating in the casting process (such as phone calls, postage, broadband/wifi/data charges etc.) will be your responsibility.
- 5.4. We shall be entitled to assign, license or sublicense the benefit of any rights or permissions granted by you under these Terms to any third party.

- 5.5. These Terms were last updated on 5 November 2024. Please note that we may update and amend these Terms from time to time and it is your responsibility to ensure you review the Terms regularly to familiarise yourself with any changes.
- 5.6. These Terms together with your application and any non-contractual obligations arising out of or in connection with it or its subject matter shall be construed in accordance with the laws of England and the parties submit to the exclusive jurisdiction of the courts of England.
