

## TERMS AND CONDITIONS

**By submitting this application form, you confirm you have read, understood and agree to the following terms and conditions:**

- 1) you satisfy each of the eligibility requirements set out in this application form and you accept that Stellify Media (NI) Ltd ("**Stellify**"/"**we**"/"**us**") shall have the right, where reasonable, to amend such eligibility requirements;
- 2) you understand that information provided will be processed for the purposes set out under, and in accordance with, our Contributor Privacy Notice;
- 3) if you are selected to participate in the Programme, you shall abide by all the rules of the Programme (as may be amended or supplemented from time to time) and shall accept Stellify's decision(s) in respect thereof as final and binding (including all decisions by Stellify concerning selection of the participants) and you agree not to challenge or appeal against those decisions;
- 4) you have answered all of the questions forming part of the application form fully, honestly and accurately, and you confirm you have not misled or attempted to mislead Stellify in any way as to your identity, experiences or in any other way. You agree to keep Stellify informed of any change to these circumstances or the information and/or data set out in this application form up to and including the date of the final transmission of the Programme. If you are found to have knowingly supplied inaccurate, misleading or false information, you understand Stellify will be entitled to exclude you from the selection process for the Programme, and if you have already taken part in the Programme, we may withdraw or require you to repay any prize you may have won;
- 6) **if you are shortlisted, you agree to authorise Stellify to conduct background checks in order to verify any of the information you have supplied and you agree to provide Stellify with any assistance, consents and/or further information necessary to facilitate such checks;**
