

## Handcuffed Series 2 (working title)

### APPLICATION TERMS & CONDITIONS

For the purposes of these Terms and Conditions:

**“Broadcaster”** shall mean Channel 4

**“Producer”** shall mean 72 Films Limited (part of Fremantle UK group of companies)

**“Programme”** shall mean Handcuffed Series 2 (working title)

By submitting this application form you hereby agree:

1. that (a) you are aged eighteen (18) years or over as at 5th May 2026; (b) must have the legal right to reside in the United Kingdom of Great Britain and Northern Ireland, the Channel Islands or the Isle of Man (“UK”) (c) that you are not currently employed by and you are not a live-in partner or immediate relative (i.e. parent, child or sibling) of an employee of the Producer, any of the Fremantle UK group of companies or the Broadcaster; and (d) you are able to be away from work and home for up to three weeks during the period from August to October (inclusive) 2026. Should your application be taken further you may be required to provide proof that you are either a British National or have the legal right to reside in the UK.
2. that, due to the anticipated high volume of applications, unsuccessful applicants may not be contacted. Submitting an application form or receiving communication from the Producer in relation to this application does not constitute an offer to participate in the Programme;
3. that if you are selected as a participant, the Producer has no obligation to produce the Programme and if the Programme is made there will be no obligation on the Producer or the Broadcaster to broadcast the Programme, but if the Programme is produced, the Programme (or any part thereof) may (at the Producer’s discretion) be broadcast, seen, used or otherwise exploited in all media throughout the world without limitations or restrictions of any kind;
4. that if you are selected to participate in the Programme you shall abide by all the rules and protocols of the Programme (as may be amended or supplemented from time to time) and shall accept that Producer’s decision as to who is selected to participate as final and binding (including all decisions regarding the selection of participants of the Programme) and you agree not to challenge or appeal against those decisions;

5. you understand that any compensation received as a result of your appearance in the Programme (if selected to participate) whether received from the Producer or otherwise, may affect entitlement to government benefits which you may otherwise be due to receive. You understand that, if you are receiving benefits, it is your responsibility to consult the relevant authority for further clarification;
6. that if you are selected for participation in the Programme, nothing in your contribution to the Programme shall be calculated to bring the Producer, Fremantle or the Broadcaster into disrepute or prejudice the successful exploitation of the Programme and any such disrepute or prejudice may result in your disqualification from the Programme;
7. that you have answered all of the questions on the application form and will answer any other questions in any other part of the selection process (and, if you are selected to participate, the production process) fully, honestly and accurately. You confirm that you have not and will not mislead or attempt to mislead the Producer in any way as to your identity, experiences, background, Criminal History (as defined below), Medical History (as defined below) or otherwise in any other way. You agree to keep the Producer informed of any change to the information and/or data set out in this application form or provided in any other part of the selection or (if you are selected to participate) production process. If you are found to have knowingly supplied inaccurate, misleading or false information at any point, you understand the Producer will be entitled to exclude you from the Programme selection process, or (if you are selected to participate) exclude you from participating in the Programme or, if you have already taken part in the Programme, you may be required to forfeit your place in the competition including any prize or any other benefit you may have received or may be due to receive;
8. if you are shortlisted, the Producer may conduct background checks in order to verify any of the information you have supplied and assess your suitability to take part. If you agree to provide the Producer with any assistance or further information necessary to do this. This could include checks of information that is publicly available online and information you have posted or shared via social media. Further information as to the basis upon which we request and process this information can be found in the 72 Films Privacy Notice;
9. you may be asked to reveal/disclose certain information about your physical health and your mental wellbeing ("Medical History") and other background information that the Producer deems necessary in order to assess your suitability to participate in the Programme. You will also be asked to reveal or disclose certain information relating to any previous criminal offences, cautions, current prosecutions, sanctions in relation to children and civil proceedings ("Criminal History") before taking part in the Programme. Further

details as to the basis upon which we request and process your information can be found in the 72 Films Privacy Notice;

10. you own all rights in the photograph(s) and/or audio visual and/or other material that you have submitted with this application form and/or may submit during the selection process and that the Producer and the Broadcaster (and their licensees and assignees) shall be entitled to copy, edit and/or otherwise use the same at their sole discretion for the purposes of making, selling, promoting and exploiting the Programme (including, if you are selected to participate, for inclusion in the Programme) or promotional material connected with it in all media, and you hereby grant the Producer and the Broadcaster (and their licensees and assigns) all necessary rights and consents for the full period of copyright to enable them to do such acts. Furthermore, you acknowledge that any images or recordings made by the Producer during the casting process, including but not limited to those that may be made during online meetings & auditions, may be used during the competition and included in the Programmes (whether you are selected to participate in the Programmes or otherwise);
11. not to discuss any information concerning the Producer, the Broadcaster, the Programme (including any photographs), your application or your possible participation in the Programme, with any other person or company, including on social media platforms whether by means of discussion, letter, press and television interviews, social media postings or otherwise, at any time without the prior written consent of the Producer;
12. you have read the 72 Films Privacy Notice with this application form;
13. you understand that once this application form has been submitted no subsequent changes will be accepted by the Producer (save as may be required to update your personal details) and that in submitting this application form you are confirming that you have read and understood the information contained within the application form;
14. you will be available at such times and locations as the Producer will reasonably require where requested;
15. if requested, you have listed and revealed all your past TV appearances and will keep the Producer informed of any further TV appearances which you may make after submitting this application form;
16. that if there is an error or omission in the Programme application form, if the application is not accompanied by any additional documentation/photographs or similar as are required by the application form, or if it is interrupted or not in fully operating condition at any point and as a result you are not able to access the application form and apply for the Programme the Producer will have no liability to you in respect thereof;

17. you are responsible for all costs associated with your accessing of the Programme application form including but not limited to: mobile network usage costs, data usage costs and costs associated with your internet provider. The Producer accepts no responsibility for any charges you may incur. The Producer recommends that for your ease in completing the Programme application form and to reduce any mobile network charges you might incur you use an available wireless network;
18. the closing date for applications for the Programme is set out on the application form website. The Producer may change the closing date and time at their sole discretion, although any changes will be reflected on the application form website;
19. that if you are provisionally selected to participate in the Programmes, confirmation of your selection will be conditional upon (among other conditions the Producer may determine at its discretion) entry into a separate contributor agreement with the Producer in the form determined by the Producer at its discretion.
