### Introduction

We, ITV Studios Limited trading as Lifted Entertainment and our subsidiary companies ("**ITVS**", "**us**", "**we**", "**our**") and our co-producer Motion Content Group Limited are producing a programme called "Love Island" (the "**Programme**"). The Programme is a reality TV series intended for initial broadcast on ITV2.

### Sensitive Information

The nature of the Programme involves us obtaining and using certain information from you and other sources (as set out in our Privacy Notice) which may be sensitive in nature concerning your mental health, your physical fitness and health, your sex life, your sexual orientation, your political opinions, your religion, your race and your criminal history (which may include allegations, on-going proceedings and/or convictions), together "**Sensitive Information**".

### Purpose, Use & Sharing of Sensitive Information

Your Sensitive Information will be processed for certain purposes and shared internally and externally, strictly on a need-to-know basis, as further described below and in our Privacy Notice:

#### Suitability to participate and wellbeing

We may ask you for certain Sensitive Information to help us to find and cast suitable contributors; as part of our duty of care and health and safety obligations to Programme participants and others (for example, to help us to protect your health and wellbeing and/or to consider the provision of reasonable support, where appropriate); and/or for insurance purposes.

We may also carry out Google and social media background checks.

Where we ask you to self-disclose your criminal history, you do not have to disclose any spent criminal convictions but we encourage you to do so if you want us to take such information into account in respect of your suitability for the Programme and/or your wellbeing.

Where we require you to undergo health assessments and/or need to share Sensitive Information with independent health practitioners, we will get consent from you separately for this.

#### Programme Content / Footage

Given the nature of the Programme, if you take part in it, some footage of you and/or about you may be sensitive in nature and/or it may involve questions or discussions (on or off screen) with you and/or with others about you covering topics relating to Sensitive Information about you.

This Sensitive Information may be used by us for the purposes of preparing, making and/or exploiting the Programme and as part of the editorial content included in the Programme.

#### Monitoring and promoting equality in opportunity and representation of diverse Programme applications

ITV is committed to having a diverse range of applicants to our programmes and contributors appearing on-screen in its programmes. We will use your Sensitive Information to promote equality in opportunity and representation for diverse applicants, and to monitor and create aggregated statistics in relation to diverse Programme applicants. We will only use the specific categories of your Sensitive Information for this purpose if you have provided this information in your application form (in the section which relates to monitoring and promoting equality in opportunity and representation of diverse Programme applications). Answering the questions in that section is entirely voluntary and answers should only be provided if you are comfortable in doing so.

Finally, as the Programme is being made with our co-producer, Motion Content Group Limited your Sensitive Information may be shared for the purposes set out above and in our Privacy Notice. Motion Content Group Limited are responsible for the personal information they hold about you and are required to maintain their own records.
